#### ORDER

- 1 .Vide paper read (1) above, university invited applications for continuation of provisional affiliation for the academic year 2023-24 from colleges for the courses affiliated to the university. In response to the same, Principal, Santhigiri Ayurveda Medical college, Palakkad vide paper read (2) above submitted application for the continuation of provisional affiliation for the year 2023-24.
- 2. On verification of the applications it was found that the college had submitted required documents along with the application and remitted necessary fee. Subsequently, university carried out an inspection at the college to assess the facilities available for conducting UG (BAMS) course with an annual intake of 50 seats and the inspection commission submitted its report vide paper read (3) above.
- 3. Vide paper read (4) above, scrutiny committee verified the inspection report at its meeting and pointed out some deficiencies, and the same were communicated to the college as per the

paper read (5) above. In response to the same, principal submitted a compliance report which was scrutinised by the scrutiny committee in its meeting held on August 10, 2023 and observed that the explanation submitted by the Principal was insufficient and recommended a surprise inspection to verify the IP/OP.

- 4. University carried out a surprise inspection at the college to verify the IP/OP, for conducting UG(BAMS) course with annual intake of 50 seats, and the inspection commission submitted its report vide paper read (7) above. The scrutiny committee verified the re-inspection report in its meeting held on September 07, 2023 and vide paper read (9) above, has recommended to grant Continuation of Provisional Affiliation to the college for conducting UG(BAMS) courses with an annual intake of 50 seats for the academic year 2023–24 and confirmed the Conditional Continuation of Provisional Affiliation granted to the college for the academic year 2022–23.
- 5. As per the paper read (8) above, Medical Assessment and Rating Board for Indian System of Medicine, NCISM, Ministry of AYUSH, Govt. of India has granted Conditional permission to Santhigiri Ayurveda Medical college, Palakkad for intake capacity in UG BAMS with 50 seats, for the academic session 2023–24 under section 28 of NCISM Act 2020.
- 6. Since the list of the colleges is to be forwarded to CEE for allotment process for the academic session 2023–24, orders are hereby issued granting Continuation of Provisional Affiliation to Santhigiri Ayurveda Medical college, Palakkad for conducting UG (BAMS) courses with annual intake of 50 seats for the academic year 2023–24, and confirmed the conditional Continuation of Provisional Affiliation 2022–23, subject to the ratification of Governing Council, as per the following conditions:
  - The college shall comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting permission to the college for conducting UG course with 50 seats in Ayurveda during 2023–24 vide letter read (8) above.
  - 2. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
  - 3. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
  - 4. Affiliation granted is strictly provisional and only for the academic year 2023–24 The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
  - 5. The College should remit annual administration fee fixed for UG/PG course for the academic year 2023–24.
  - 6. Admission to the next academic year shall be made only after obtaining prior permission
