Sub: Ayurveda/Siddha/Unani (ASU) Courses 2022-23- Request submitted by the President, Kerala State Indian System of Medicine Self- Financing College Management Association (KISMA) to fill up the vacant seats- Direction issued- Matters- Reg.

In pursuance of the order cited 1st paper above, you have submitted joining/non joining statistics in respect of 13 member colleges that come under your Association in relation to the admission of students in the management quota seats as on 05.02.2023, as per the reference cited 2nd above, wherein it is stated that after completion of the admission procedure, there are more than 60 seats lying vacant under management quota in the member colleges and hence you have requested the Committee to permit the

NEET qualified candidates including NK-II category of students in the vacant seats as per the fees stipulated by the Fee Regulatory Committee.

The Committee has gone through the submissions made by you and found that there are vacancies to be filled under the management quota in the member colleges that come under KISMA. Considering the above fact and the number of vacancies remaining unfilled in the member colleges, the Committee accord sanction to invite fresh online applications from the aspirants for filling up the vacant seats as per the conditions shown below.

- (a)** As far as BAMS Courses in the Ayurveda Colleges are concerned, application from 'NEET' qualified candidates alone shall be entertained.
- (b)** As far as BSMS and BUMS courses in the respective colleges are concerned, applications from 'NEET' qualified candidates coming within NK-II category alone shall be entertained.
- (c)** In case there arises the need to invite applications to accommodate NK-II category candidates qualified in NEET examination in the Ayurveda Colleges, the same can be done by those colleges after obtaining the requisite permission from the Government.
- (d)** Entire admission procedure pertaining to the inviting of applications by

online and giving admissions to the eligible candidates observing inter se merit shall be completed on or before 18th February 2023 and the fact reported immediately to this Committee.

- (e) The President, KISMA, shall communicate this direction to all-member colleges that come under the KISMA.
